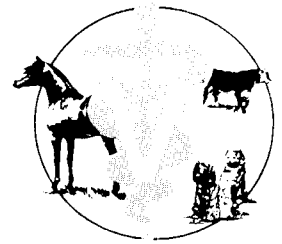

During the care, treatment and safe keeping of your animal, all reasonable precautions against injury, escape or destruction to your animal(s) or your possessions will be used, but BAH or staff will not be held liable or responsible in any manner for things beyond our control. It is thoroughly understood that I assume all risks in regards to my animal(s) being treated or boarded. BAH may treat my animal for issues deemed as medically necessary by BAH veterinarian, and I agree to pay all associated costs. BAH will make all reasonable efforts to contact you prior to such treatment, unless such delay threatens the life or long term health of your animal.

If the animal(s) remains after the expected date of pick up, BAH will attempt to contact the owner or emergency contact person. If the owner is unable to be contacted, BAH will mail a written notice to the address contained on this form. Seven days after the written notice is mailed and if BAH has not been contacted, BAH will consider the animal abandoned and may dispose of or destroy the animal as it deems fit. Disposing or destroying my animal does not relieve me from my obligation to BAH in paying all cost associated with my animal(s) including the cost of disposing or destroying.

If you pet damages beds, walls, doors, etc., during its stay, you may be expected to pay for repairs and replacements. We understand that pets will be pets, they may scratch walls and doors, as well as chew on their bedding, but any property damage in excess of \$50.00 will be billed to you.
